	Supplier of dangerous substances	<ul style="list-style-type: none"> . Send the Safety Data Sheets for hazardous substances. . Supply only products that comply with applicable safety and environmental standards, prioritizing and informing about alternatives that are more respectful with the environment or that improve their life cycle.
	Subcontracting of other and maintenance services	<ul style="list-style-type: none"> . Municipal ordinances and regional legislation must be complied with regarding maximum levels of noise in the work and work schedules. Los vehículos utilizados en el transcurso de la obra deben tener superada la inspección técnica oficial. . It is totally forbidden to dump any dangerous substance, both to the sanitation network and to the treatment plant. . When it is believed that a spill may be generated, it must be previously communicated to the Manager in order to process the corresponding authorization or prepare the appropriate preventive measures. . The cleaning with water of containers that have contained dangerous substances is not allowed. If cleaning should be carried out on containers, drums or containers with dangerous substances or tools or machinery with dangerous products should be cleaned, this cleaning should be done with rags or paper in a place specially prepared for this purpose and conditioned in such a way as to avoid spill of dangerous products to the ground (containment tray, waterproof tarpaulins or similar). Cleaning cloths must be managed as hazardous waste. . Accidental spillages of hazardous substances should be collected with absorbent material and subsequently treated as hazardous waste. In any case, you must notify the person in charge of the plant. . It is forbidden to pour concrete remains in an uncontrolled manner in the vicinity of the work. . It is under the responsibility of the subcontractor any spillage caused by its activity, in any case must comply with current legislation on discharges. . The subcontractor must respect the specifications of the client that will be delivered to him. . The abandonment of waste or its uncontrolled dumping on land, drains, collectors or waterways is prohibited. . A selective classification of the waste must be made from the moment it is produced. . Each type of waste must be stored properly. Containers, sacks, bags or collection systems will be used to prevent their dispersion. . The area where the containers are placed must be marked and identified . It must be responsible for the storage and management of the waste generated by its work, by handing it over to an authorized manager and following at all times what is indicated by current legislation. . It must be sent to the company, the documents that prove the waste management by authorized manager. . In general, any hazardous waste generated by the subcontractor during the work will be the responsibility of the subcontractor, who must bear the costs of its management. . The plant has a waste storage area classified by type . If the subcontractor uses this Clean Point at any time, it will notify the Manager and respect the conditions of use. . The work areas will be kept clean and in order at all times.
